Based on paragraph 11 sub-paragraph 11.1. - Annex 4 from the Ministry of Economy - Procurement procedures for persons who are not liable to the Public Procurement Act by the client's Radlovac dd, a board member Nenad Sabljak issues the following,

DECISION

the cancellation of the procurement

I. CLIENT AND SUBJECT OF PURCHASE FOR THAT BRINGS DECISION ON CANCELLATION

Article 1.

The client Radlovac dd, Trg pl. Mihalovića 12, 33515 Orahovica, VAT No.: 19862947689 (hereinafter: the client) cancels the open procedures for the procurement Facility for the production of fine fractions of dolomite aggregate, Publication reference: Supplies 1/2016, published on July 11, 2016 on the official website of the client.

II. EXPLANATION OF REASONS ANNULMENT

Article 2.

The client is on July 11, 2016, on its official website www.radlovac.hr announced the procurement being conducted under the designation of point I. of this Decision, on the basis that the offerer submitted their offer.

02 August 2016, starting at 04.00 p.m. started the opening of offers. The client received only one offer. Offer was from the CDE Global Limited, Ballyreagh Industrial Estate, Cookstown, Co.Tyrone, N.Ireland BT80 9DG.

In the process of examination and evaluation of 02 August 2016, it was determined that the only received offer is invalid.

The offerer CDE Global Limited, Ballyreagh Industrial Estate, Cookstown, Co.Tyrone, N.Ireland BT80 9DG, failed to prove the absence of mandatory reasons for exclusion, since it did not provide a certificate of tax and/or other equivalent document and/or declaration (in accordance with section 4.2. of the Tender documentation) which prove that there is no debt on the basis of public duties.

Given the above, it was decided as in Article 1 of this Decision.

III. STANDSTILL PERIOD

Article 3.

The Decision on the cancellation becomes enforceable its delivery to all bidders in accordance with Article 4 of this Decision.

Article 4.

This Decision shall be published in the official website of the client where the delivery is considered published expiry of the date of publication.

IV. TIME STARTING A NEW PROCEDURE FOR THE SAME OR SIMILAR SUBJECT OF PROCUREMENT

Article 5.

Contracting authority will at the latest within 15 days from the date of enforceability of the Decision to initiate a new procedure for the same subject-matter plant for the production of fine fractions of dolomite aggregate.

V. AVAILABLE LEGAL REMEDY

Article 6.


This decision may be appealed within eight (8) days of receipt of this Decision. The appeal shall be filed with the Croatian Agency for Small Business, innovation and investment, in writing. Simultaneously with the submission of complaints to the Agency shall deliver a copy of the Client demonstrably.

The appeal should be sent directly, by mail or by electronic mail, means if they have achieved a mutual conditions of delivery of electronic documents in accordance with the regulation on electronic signature.
